SUMMARY

The Los Angeles Fire Department (LAFD) entered into an Agreement (C-127704) with Partners in Diversity, Inc. on June 23, 2016 for temporary accounting and auditing support. Due to prolonged staffing shortage in the Administrative Services Bureau, LAFD requires continued services from Partners in Diversity, Inc. Such as-needed assistance has been a continuing need to meet peak workload demands.

The LAFD desires in this First Amendment to increase the maximum compensation amount of the Agreement from \$140,000 to \$190,000. The contract will be funded through LAFD's Contractual Services Account.

RECOMMENDATIONS

That the Board:

Approve, and transmit to the Mayor in accordance with Executive Directive 3, the First Amendment with Partners in Diversity, Inc., for temporary staffing services on an asneeded basis.

FISCAL IMPACT

The Los Angeles Fire Department has identified funds in its Contractual Services Account to cover expenses related to this Agreement.

FIRST AMENDMENT TO AGREEMENT NO. C-127704 BETWEEN THE CITY OF LOS ANGELES AND PARTNERS IN DIVERSITY, INC.

This Agreement (hereinafter referred to as "AGREEMENT") is made and entered into by and between the City of Los Angeles, a municipal corporation (hereinafter referred to as "CITY"), acting by and through the Los Angeles Fire Department (hereinafter referred to as "LAFD"), and Partners in Diversity, Inc. (hereinafter referred to as "CONTRACTOR") with reference to the following:

WHEREAS, the LAFD requires temporary accounting and auditing; and

WHEREAS, the provision of seasonal, temporary staff support for the LAFD is most efficiently handled through a contractual arrangement between the CITY and a personnel services agency; and

WHEREAS, pursuant to Los Angeles City Charter Section 1022, the CITY has determined that the work can be performed more economically or feasibly by independent contractors than by CITY employees; and

WHEREAS, the necessary funds are available in the LAFD budget and the funds have been appropriated for such purpose; and

WHEREAS, the Parties entered into Agreement C-127704, on June 23, 2016, wherein CONTRACTOR agreed to provide temporary staff support for the LAFD; and

WHEREAS, the CITY desires in this First Amendment to increase the maximum compensation amount by \$50,000, which increases the maximum compensation from \$140,000 to \$190,000; and

NOW, **THEREFORE**, in consideration of the above premises and of the covenants and representation set forth below the parties covenant and represent as follows:

Section VII, COMPENSATION AND METHOD OF PAYMENT, Paragraph A, is hereby amended to read:

A. The CONTRACTOR shall be paid as compensation for complete and satisfactory performance of the terms of this AGREEMENT, an amount not to exceed one hundred and ninety thousand dollars (\$190,000), to be paid based on the pricing schedule of services, listed in Exhibit A, which is attached to this AGREEMENT and incorporated herein. The

LAFD makes no guarantee of work or minimum amount of payment to CONTRACTOR.

Except as herein amended, all other terms and conditions of this AGREEMENT shall remain unchanged.
