#### SUMMARY

As directed by the Board of Fire Commissioners, the Fire Department is providing an updated Fire Prevention and Public Safety Bureau (FPB) Action Plan. This Action Plan allows the FPB to set achievable overall goals to create our business plan and to develop a pathway to achieve them. The overall time frame to achieve these specific goals will commence on July 1, 2017 and conclude on June 30, 2018.

## DISCUSSION

The FPB is fully dedicated to reducing risk and preventing fires through education, fire inspections, active code enforcement, plan review, vegetation management, and by identifying and mitigating fire hazards. This proactive and preventative approach reduces the loss of life and property, as well as, protects the environment. The FPB is determined to decrease the statistics and severity of all fires. To prevent fires or other emergencies from occurring in the first place is an effective way to protect life, property and the environment.

The following is the new vision of the FPB:

The FPB provides exceptional and unparalleled public safety through timely and thorough fire code inspection and enforcement. This will be accomplished by being the best trained, professional and experienced technical experts in the history of the Los Angeles Fire Department's FPB focusing on the community and industries we serve.

The following is the mission of the FPB:

The overall mission of the FPB is to make the City of Los Angeles safe through prevention, preparedness, inspections and enforcement.

The FPB has established five primary goals, all of which focus on achieving our vision and mission.

- 1. Make the City of Los Angeles safe by reducing the overall number and severity of fires.
- 2. Promote and explore new technologies for increased efficiencies, training and education delivery.
- 3. Provide quality customer service to both internal and external stakeholders.
- 4. Provide the necessary infrastructure to support high performance enhancements throughout the FPB.
- 5. Complete the inspection cycle on all identified hazards with 100% re-inspections resulting in compliance or legal enforcement after 45 days.
