SUMMARY

The Los Angeles Fire Department is submitting a donation request from the First-In Fire Foundation for services including design, landscaping, storage, delivery, and installation of the Firehouse Centennial Garden at Fire Station 29, valued at \$62,125. The scope of work includes a two-year maintenance period and covers the front and side yards from Wilshire north to the driveway on Van Ness and money for the pickup and storage of boulders from Mr. and Mrs. Jeffrey Levine that provides a \$16,000 saving to this project.

RECOMMENDATIONS

That the Board:

- 1. Receive this report for the approval of funding by the First-In Fire Foundation for the items listed above, valued at \$62,125, to the Los Angeles Fire Department.
- 2. Request the Commission Executive Assistant to transmit this report to City Council in accordance with the Los Angeles Administrative Code, Ordinance 15514, Article 12, Section 5.111.4, for consideration and approval.

FISCAL IMPACT

There is no fiscal impact to the Department's budget from the acceptance of this donation.

Here is a summary of the costs for design and installation for Fire Station 29, with scope of work to include the front on Wilshire Blvd. and the side yard from Wilshire north to the driveway on Van Ness.

Landscape Boulders

(\$16,000)

One of the design ideas is the creation of a dry streambed with appropriate planting and boulders. Mr. and Mrs. Jeffrey Levine of Encino have generously offered to give us boulders they have on site purchased for a prior project but are not needed now. An earlier quote from NatureScape included the cost of the purchase and delivery of boulders at \$16,000. The Levine's gift allows us to remove \$16,000 boulder purchase and delivery from the current bid.

The current bid from NatureScape does, however, include a bit of money so that they can go the Levine residence, pick up the boulders and store them until we can use them on Fire Station 29.

Ongoing Maintenance (2-year period)

\$8,240

3 visits/year to replace mulch, limited plant replacement for die-back, check and adjust irrigation, site-clean-up, limited weeding.
