SUMMARY

Los Angeles Municipal Code Section 11.04 (Ch. 1, Art. 1) provides that any Board, Commission, or Head of a Department may prepare a report setting forth findings regarding the status of unpaid accounts. This report may then be submitted to the Collections Board of Review for appropriate actions. Submitted for this write-off request are 60 uncollected charges for services of fire safety officers and inspection fees billed in Fiscal Years 2009-10 through 2016-17 (September 2009 through January 2017) each valued less than \$5,000.00 amounting to \$30,896.30.

These accounts were billed following Citywide Collection Guidelines. They were referred to the City's contractor, Transworld Systems, Inc., and then for an additional six month secondary collection with Caine and Weiner or Municipal Services Bureau. These accounts were subsequently deemed to be uncollectible and were returned to the Los Angeles Fire Department (Department) between October 2016 and August 2018. Accounts totaling 41 are past the statute of limitations.

In line with Citywide Collection Guidelines, the staff of Accounting Services determined that the attached list of unpaid accounts amounting to \$30,896.30 should be written off.

RECOMMENDATIONS

That the Board:

1. Authorize the Fire Chief to refer to the Collections Board of Review all pertinent documentation regarding \$30,896.30 in uncollectible accounts for write-off authority.

2. Forward the attached letter and summary reports to the Collections Board of Review for consideration and approval.

FISCAL IMPACT

With the removal of these uncollectible accounts from the Department's outstanding balance, the Department's resources are more efficiently utilized on more recent outstanding accounts. The removal of these unpaid accounts from the City's Financial Management System shall not preclude the City from collecting any sum that later proves to be collectible. Writing off these accounts would be consistent with Generally Accepted Accounting Principles. This is also consistent with existing City policy to reflect the accurate status of accounts in the City's financial statements so as not to overstate the revenue.

Write-Off of Uncollectible Los Angeles Fire Department
Charges for Services Each Valued Less Than \$5,000
for Fiscal Years 2009-10 to 2016-17 (From September 2009 through January 2017)

Los Angeles Administrative Code, Chapter 11, Article 1, Section 5.182, provides that the Fire Chief of the Los Angeles Fire Department (LAFD) shall review the status of unpaid ambulance accounts to determine whether they are collectible. He shall refer those accounts determined to be uncollectible to the Collections Board of Review in accordance with the Los Angeles Municipal Code, Article 1, Section 11.04, for appropriate action. The write-off of these unpaid accounts shall not preclude the City from collecting any sum that later proves to be collectible.

Submitted for this write-off request are 60 accounts, originating from Fiscal Years 2009-10 through 2016-17 (September 2009 through January 2017), each valued less than \$5,000, for uncollected Fire services amounting to \$30,896.30. Accounts totaling 41 are now past the statute of limitations.

It is recommended that the Collections Board of Review approve the write-off of \$30,896.30 from 60 uncollected Fire service accounts for Fiscal Years 2009-10 to 2016-17 (September 2009 through January 2017), each valued less than \$5,000.

- 1. Los Angeles Administrative Code, Chapter 11, Article 1, Section 5.182, provides that the Fire Chief of the LAFD shall review the status of unpaid accounts to determine whether they are collectible. He shall refer those accounts determined to be uncollectible to the Collections Board of Review in accordance with Section 5.182 of the Los Angeles Administrative Code for appropriate action.
- 2. All of these accounts were billed following Citywide Collection Guidelines. They were referred for additional collection efforts to the City's contractor, Transworld Systems, Inc. and then were referred for an additional six months with the City's secondary collection agencies, Caine and Weiner or Municipal Services Bureau. The accounts were subsequently deemed to be uncollectible and were returned to the LAFD from October 2016 through August 2018. Accounts totaling 41 are past the statute of limitations. The LAFD's resources are more efficiently utilized on more recent outstanding accounts.
- 3. Writing off these accounts would be consistent with Generally Accepted Accounting Principles. This is also consistent with existing City policy to reflect the accurate status of accounts in the City's financial statements and not overstate revenue.
- 4. The following write-off criteria per Citywide Collection Guidelines have been met:
 - a. The amounts are uncollectible;
 - b. The write-off will not prejudice the position of the City;
 - c. All reasonable collection efforts have been exhausted:
 - d. The debtor cannot be located or due to difficult to collect reasons; and
 - e. The applicable statute of limitations for 41 accounts for collection of debt has expired. The write-off of unpaid 19 accounts still within statute of limitations shall not preclude the City from collecting any sum that later proves to be collectible.
