The Los Angeles Fire Department Foundation has provided a donation for a Hercules 18x20 ft. white canopy and a 18x20 ft. white drawstring cover, valued at \$407.94. The equipment has been generously donated to the Los Angeles Fire Department (LAFD) to preserve the plug buggy from the weather.

Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, not exceeding \$5000.00 in market value shall be submitted to the Board of Fire Commissioners for acceptance or rejection.

Approve this report and accept the In-Kind Donation from Los Angeles Fire Department Foundation, for the items listed above, valued at \$407.94 to the Los Angeles Fire Department.


