## **SUMMARY**

Burlington Northern Santa Fe Railway seeks to donate to the Los Angeles Fire Department (LAFD) a decommissioned rail car to enhance the LAFD's hazardous materials training. The rail car prop will be used to train First Responders, HazMat Technicians and Specialists, as well as regional partners who operate within the Port of Los Angeles complex. The rail car prop will be outfitted and equipped in collaboration with BNSF, Union Pacific Railway, the LAFD Foundation, and the California Specialized Training Institute (CSTI). The prop and all necessary accessories are specifically outlined in California Code of Regulations (19 CCR § 2560). The rail car will be located on Terminal Island at the LAFD's Hazardous Materials regional training site. The value of the rail car and accessories is estimated between \$20,000.00 and \$40,000.00.

## RECOMMENDATIONS

That the Board:

- 1. Receive this report for the In-Kind Donation by BNSF Railway for the items listed above, valued at between \$20,000.00 and \$40,000.00 to the Los Angeles Fire Department.
- 2. Request the Commission Executive Assistant to transmit this report to the Mayor's Office in accordance with Executive Directive No. 3 and to City Council in accordance with the Los Angeles Administrative Code, Ordinance 15514, Article 12, Section 5.111.4, for consideration and approval.

## FISCAL IMPACT

There is no fiscal impact to the Department's budget from the acceptance of this donation. Donations provide the necessary items meeting the needs of the respective fire stations or administration sections. Replacement or repair of items meeting City specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.
