## SUMMARY

The Los Angeles Fire Department Foundation (LAFDF), through its Adopt-A-Fire-Station program, has graciously donated lumber supplies to Fire Station 10 in Downtown LA for the purpose of constructing a new door leading to the station's workroom. The upgrade will provide a modern door for the members of the station to use the workroom to complete projects and maintain tools, equipment, and safety gear. The value of the donation is \$1,007.04.

Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, not exceeding \$5000.00 in market value shall be submitted to the Board of Fire Commissioners for acceptance or rejection.

## RECOMMENDATION

That the Board:

Approve this report and accept the In-Kind Donation of lumber for a new door from the LAFDF's Adopt-A-Fire-Station program valued at \$1,007.04 to the Los Angeles Fire Department.
