## SUMMARY

The Los Angeles Fire Department Foundation (LAFDF), through its Adopt-A-Fire-Station program, has graciously donated health and wellness equipment to Fire Station 71 in Holmby Hills. The purpose of the equipment is to allow firefighters to maintain the necessary fitness levels to perform the often physically demanding fitness duties required in the course of their workday. Due to COVID-19, LAFD members have been unable to patronize private gyms on their off-days, so having proper fitness equipment at the fire station is of paramount importance for their health, wellness and readiness to perform their job functions. The value of this donation is estimated at \$4,741.29

Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, not exceeding \$5000.00 in market value shall be submitted to the Board of Fire Commissioners for acceptance or rejection.
