SUMMARY

The Los Angeles Fire Department Foundation (LAFDF), through its Adopt-A-Fire-Station program, has graciously a commercial-grade ice-maker to FS 46 in South Los Angeles. The current ice-maker is no longer working. A functioning ice-maker is required to help keep firefighters properly hydrated at the station while in the course of their normal duties, including training drills and daily health and wellness periods. Additionally, ice is carried in coolers on apparatus for hydration needs at emergency incidents, including structure fires and during brush fires. The value of this donation is \$1,599.80.

Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, not exceeding \$5000.00 in market value shall be submitted to the Board of Fire Commissioners for acceptance or rejection.

RECOMMENDATION

That the Board:

Approve this report and accept the In-Kind Donation of a commercial-grade ice-maker from the LAFDF's Adopt-A-Fire-Station program valued at \$1,599.80 to the Los Angeles Fire Department.

There is no fiscal impact to the Department's budget from the acceptance of this donation.
