Attached for the Board of Fire Commissioners review is the current monthly Paramedic Vacancy Projections Report from the Office of the Chief of Staff.

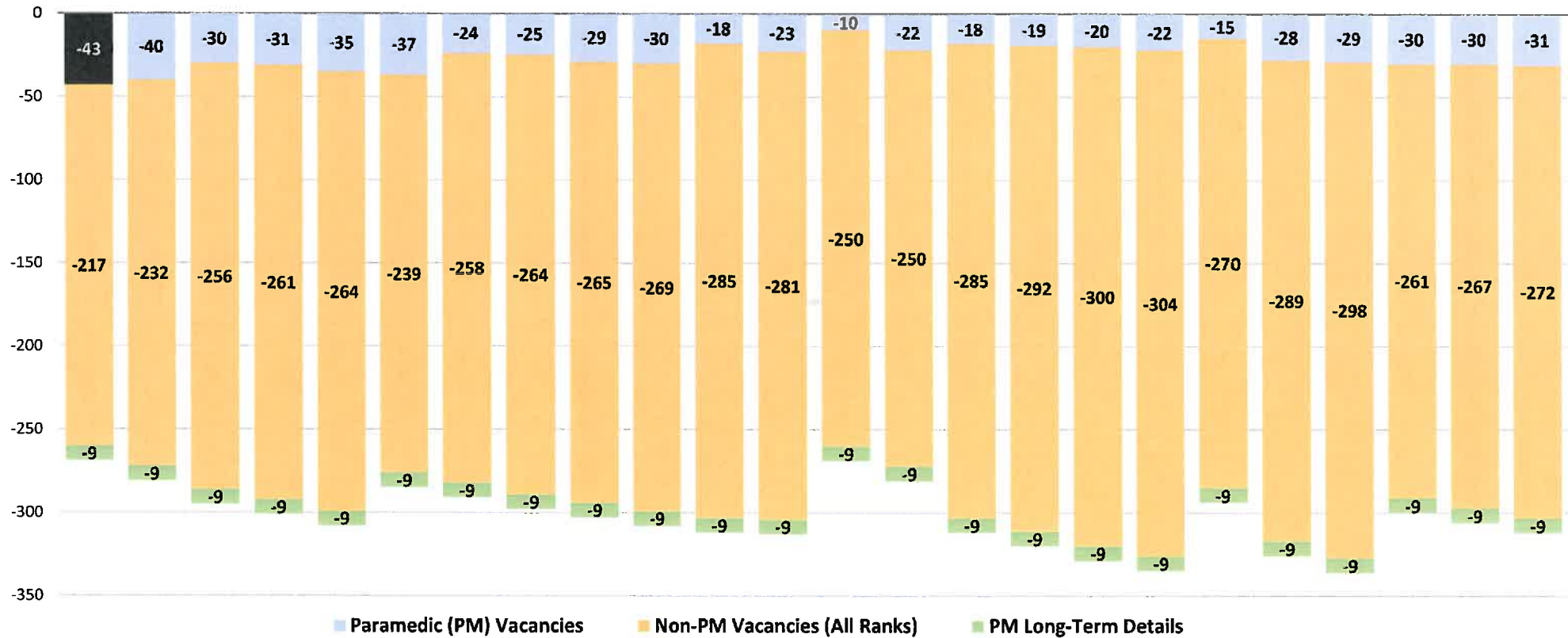
