SUMMARY

Los Angeles City Fire Department utilizes RX10 tablets across the department to capture electronic Patient Care Reports (ePCR) during EMS 911 responses. The mobile devices are used frequently therefore the normal wear and tear is exponentially greater. When devices are damaged, they are decommissioned from the field and sent for repair. The device's hand strap provides extra protection and allows the user to securely grip onto the device. Getac, the maker of RX10 devices, has donated 550 hand straps to replace our aging hand straps. Replacing the old hand straps will protect the devices from further damages and allow LAFD to get more usage out of the devices. The value of the donation is \$119.

Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, not exceeding \$5000.00 in market value shall be submitted to the Board of Fire Commissioners for acceptance or rejection.
