STATUS REPORT ON THE REIMBURSEMENT CLAIMS FOR THE

TOPANGA BRUSH FIRE, HURRICANE KATRINA, AND HURRICANE

RITA

As a result of a discussion at the Board of Fire Commissioners' meeting October 3, 2005, and subsequent meetings, direction was given to provide the status of the Topanga Brush Fire claim for reimbursement. This report will address the status of the claims for the Topanga Brush Fire, Hurricane Katrina, and Hurricane Rita. The total cost recovery for the Topanga Brush Fire, Hurricane Katrina, and Hurricane Rita is \$5,644,251. To date, the LAFD has received \$2,056,090 in reimbursements for Hurricanes Katrina and Rita. The outstanding balance owed is \$3,588,161.

Status of Claims

Topanga Brush Fire - Two claims were submitted on February 10, 2006, for the Topanga Brush Fire. One claim was submitted to the California Department of Forestry and Fire Protection (CDF) for \$1,773,638. The second claim was submitted to the Office of Emergency Services (OES) as a Fire Management Assistance Grant (FMAG) for \$717,812.

The claims were based on the cost share agreement, which was negotiated by the incident commanders from CDF, National Park Service (NPS), Los Angeles County (LAC), Ventura County (VNC), and Los Angeles Fire Department (LAFD).

Based on conversations with representatives from both CDF and OES, it is anticipated that their remittance will be received within 90 days or approximately May 11, 2006.

The direct cost of the Topanga Brush Fire was \$1,797,993 (The personnel costs were \$1,738,504 and the expenses were \$59,489). The total cost recovery is \$2,491,450. The difference between the direct costs and the reimbursements is attributed to the allowable equipment usage rates.

Hurricane Katrina - The reimbursement claim for Hurricane Katrina was submitted on December 28, 2005, in the amount of \$2,313,137. This amount includes personnel, equipment and services, and administrative costs. Federal Emergency Management Agency (FEMA) has remitted \$1,536,748 for 75% of the personnel costs. Once FEMA finalizes their review of the claim, the remaining balance will be remitted to the City.

Hurricane Rita - The reimbursement claim for Hurricane Rita was submitted on December 28, 2005, in the amount of \$839,662. This amount includes personnel, equipment and services, and administrative costs. FEMA has remitted \$519,342 for 75% of the personnel costs. Once FEMA finalizes their review of the claim, the remaining balance will be remitted to the City.

CONCLUSION

The Fire Department has worked with the CAO to ensure funds are available to pay for the expenditure of the Topanga Brush Fire and the remittance from both CDF and FEMA will more than cover the direct costs incurred. The remittance from CDF and FEMA will be deposited into the General Fund Receipts.

Attached, for your information, is the status of all claims made in fiscal year 2004-2005 and fiscal year 2005-2006 (Attachment A). Follow-up is conducted on accounts over 60 days outstanding, but this information was not tracked in the system until January 2006. Additional information (Attachment B) is provided on accounts that are over 60 days outstanding.
