Summary.

Periodically a member of the public, or an organization, will make a donation to the Los Angeles Fire Department in support of the programs and activities it performs. Many of these donations are "in-kind", meaning something that is physically donated, i.e. exercise bike, tv chair, television, etc.

We are asking the Board to accept the following "in-kind" donations on behalf of the Fire Department:

- 1. Firemen's Fund Insurance Company has a long history of generously donating equipment and/or money to this Department. The first donation includes an equipment and software package valued at \$4,901.46. (Please see attached letter.)
- 2. The second donation being made by the Firemen's Fund Insurance Company includes audio and visual communications equipment valued at \$20,098.54. Since this donation exceeds the \$5,000 threshold, it must also be approved by the City Council. (Please see attached letter.)
