2008-2009 Update of Fees for Emergency Ambulance Services

In accordance with Executive Directive Number FM-3, a recommendation for an increase in fees for emergency ambulance services is submitted for your consideration. The recommendation is based on the most recent cost recovery schedule and has been reviewed and concurred by the City Administrative Officer.

RECOMMENDATIONS

It is recommended that:

- 1. The Advanced Life Support (ALS) response and transport fee be increased 12.88% from \$889 to \$1,004.
- 2. The Basic Life Support (BLS) response and transport fee be increased 14.47% from \$622 to \$712.
- 3. The Mileage rate be increased 8.62% from \$14.50 to \$15.75 per one-way mile traveled per patient.
- 4. The City Attorney be instructed to prepare and present an Ordinance within 30 days with similar effect to that proposed in this report, that would amend the Schedule of Charges for Emergency Service Table, found in Los Angeles Administrative Code Sec. 22.210.2, to reflect the changes in ALS, BLS, and mileage rates. Once approved, the Ordinance is to be submitted forthwith to the Mayor for signature.

Table 2 compares proposed LAFD rates to proposed Los Angeles County rates. LAFD's proposed ALS fee is 2.19% (\$22) higher than Los Angeles County. LAFD's proposed BLS fee is 1.71% (\$12) higher than Los Angeles County. The LAFD proposed ALS fee and the proposed BLS fee include the cost of medical supplies whereas the Los Angeles County proposed rates do not include the cost of medical supplies. The Los Angeles County charges medical supplies based on the specific supplies used. There is no difference in one-way mileage fee.

REVENUE

The estimated effective date of the fee increase is October 1, 2008. Based on the estimated effective date of fee increase, revenue for Fiscal Year 2008-2009 is expected to be \$56,383,618. This revenue has already been included in the Council approved Fiscal Year 2008 – 2009 budget.
