## EMS DEPLOYMENT PLAN APRIL 2009 UPDATE

APR 2 - 2009 JOINT COMMITTEE

The EMS Deployment Plan, approved by the Fire Commission on October 3, 2006, has addressed the Fire Chief's goals to increase paramedic coverage, improve overall EMS service delivery, and provide a better working environment by providing more rotational paramedic assignments.

The six objectives of the current five-year EMS Deployment Plan are:

- Deploy a Paramedic Ambulance at every fire station
- Provide full Paramedic rotation with Paramedic Assessment fire companies at every station
- Reduce Paramedic Response Times
- Create a Paramedic Field Training Officer Program
- Establish a LAFD Paramedic Training Academy
- Improve EMS Management and Supervision

Nearly one year ago, on April 27, 2008, 15 BLS fire companies were upgraded to Paramedic Assessment status at 15 fire stations in Battalions 3, 13, 14 and 18. This increase in paramedic resources, along with the ability of Firefighter-Paramedics to rotate between the Paramedic Ambulances and the Assessment fire companies, was evaluated for its impact on response times, resource workload, and meeting the desired objectives.

During the first six months following deployment of these 15 additional Paramedic Assessment resources, paramedic response times were reduced in all of these 15 fire station first-in districts. The fire station districts in the San Fernando Valley had paramedic response time improvements from 6% to 13%. The fire station districts in South Los Angeles had paramedic response time improvements from 12% to 26%.

This year's budget provided resolution authority, without funding, for 18 EMS Battalion Captain positions that were deleted in the budget. All 16 EMS Battalion offices remained open and staffed with regularly assigned EMS Battalion Captains. Together, labor and management were able to identify funding and obtain City Council approval to staff the 18 positions for the rest of this year.

The EMS Deployment Plan was not funded for 2008-2009. There are no funds to implement any more resources. There are no plans to increase the number of rotational paramedic assignments or the number of paramedic resources during the next year. There is no funding to establish an LAFD Paramedic Training Academy, or create a Paramedic Field Training Officer Program during the next year. There is funding to send up to 45 Firefighters to Paramedic School this year.

In 2007-2008, the Department hired 62 new Firefighters that were already licensed paramedics, and 37 Firefighters completed Paramedic School. Since July 2008, the Department has hired 48 new Firefighters with paramedic licenses, and 27 seasoned Firefighters have started Paramedic School.

Since July 29, 2008, the LAFD has 106 fire stations and these resources:

- 130 Ambulances 89 Paramedic and 41 BLS
- 101 Engine Companies 45 Paramedic and 56 BLS
- 49 Light Forces 16 Paramedic and 33 BLS
- 5 Fireboats 1 Paramedic and 4 BLS
- 5 Helicopters 1 Paramedic Air Ambulance
- 86 Fire Stations have a Paramedic Ambulance
- 61 Fire Stations have a Paramedic Fire Company
- 49 Fire Stations provide rotation for the Firefighter-Paramedics
- 46 Fire Stations have two Paramedic resources
- 24 Fire Stations have two Rescue Ambulances
