Summary.

Fire Station 9 has an opportunity to accept an in-kind donation from a private citizen, Mr. Steven Needleman. The members of Fire Station 9 have identified several tools that they would like to add to their Station's inventory. These tools will make it possible for members to make minor repairs and also to build necessary shelving, storage, etc., which will help them to better organize their equipment, tools, supplies, etc.

Following is the list of items being requested by Fire Station 9, with their approximate value:

1. DieHard Battery Charger - \$139.99
2. Craftsman 432 Pc. Mechanics Tool Set - \$615.99
3. Samsonite 8' Rectangular Tables (5) - \$439.90
4. Craftsman 12 gal. Wet/Dry Vac - \$79.99
5. Craftsman ½" Pneumatic Impact Wrench - \$179.99
6. Craftsman 48 pc. Impact Socket Set ½" - \$179.99
7. Creeper Seat/High Back - \$213.98
8. Craftsman 1000 Watt Tripod Light - \$41.99
9. Free Standing Cabinets (Workroom) - \$5408.58
10. All Steel Folding Chairs (20) - \$199.60
