SECOND AMENDMENT TO EXTEND THE WEED AND REFUSE

ABATEMENT CONTRACTS

Recommendations: That the Board:

- 1. Approve the extension of the Agreement as outlined in the Second Amendment to cover the 2010-11 Fiscal Year.
- 2. Direct the Commission Executive Assistant II to transmit the Second Amendment to the 2008 Agreement to the Mayor and City Council for review and approval in accordance with Executive Directive No. 3.

Summary:

The ongoing effort to provide public safety through the enforcement of the Brush Clearance Ordinance requires the Brush Clearance Unit to inspect approximately 130,000 properties per year. On the average, 800 to 1,200 properties are cleared by the Fire Department. The use of private contractors to abate a public nuisance has proven to be both necessary and cost effective.

The work itself has been deemed to be too hazardous for City employees to perform in accordance with their Memorandum of Understanding. Therefore, other City departments, such as Street Services, Department of Water and Power, or Recreation and Parks, cannot perform the work.

FINDINGS:

The 2008 Agreement was with 18 companies that possessed both the skills and knowledge of what is required by the Fire Department. However, only 14 names will be recommended to have their contracts extended at this time (please see attachment).

SECOND AMENDMENT TO AGREEMENT NO. <<INSERT CONTRACT NO.>> BETWEEN THE CITY OF LOS ANGELES AND <<INSERT COMPANY NAME>> TO PROVIDE BRUSH CLEARANCE, WEED AND/OR REFUSE ABATEMENT

THIS SECOND AMENDMENT to Agreement Number <<INSERT CONTRACT NO.>> between the City of Los Angeles, a municipal corporation (hereinafter referred to as the "CITY), acting by and through the Los Angeles FIRE DEPARTMENT (hereinafter referred to as the "DEPARTMENT"), and <<INSERT COMPANY NAME>> (hereinafter referred to as the "CONTRACTOR), is entered into with reference to the following:

WHEREAS, the DEPARTMENT requires the services of qualified CONTRACTORS to abate hazards located in the Very High Fire Hazard Severity Zone, on improved and unimproved property within the CITY; and

WHEREAS, on July 1, 2008 the DEPARTMENT contracted qualified CONTRACTORS with sufficient crews and equipment to furnish said abatement services in a timely manner; and

WHEREAS, CONTRACTOR acknowledges having attended the required orientation sessions resented by the DEPARTMENT regarding the Brush Clearance Program (program\, and further; acknowledges having received and reviewed all related documents about the Program distributed by the DEPARTMENT to potential CONTRACTOR'S. The CONTRACTOR understands the Program requirements imposed under this Agreement and the Los Angeles Municipal Code.

WHEREAS, CONTRACTOR acknowledges that grounds for termination of this AGREEMENT include, but are not limited to, solicitation of monetary fees from a property owner whose parcel is part of a bid package, before, during or after abating a fire hazard on such parcel.

WHEREAS, the parties agree to amend this AGREEMENT to extend the term for one additional year and to make technical revisions.

The parties amend this AGREEMENT is as follows:

- ARTICLE 2. TERM THE AGREEMENT is amended to read in its entirety as follows:
 - A. The term of this Agreement will commence on July 1, 2008 and will terminate on June 30, 2011, unless otherwise terminated by the DEPARTMENT.
- 2. ARTICLE 3.E.2 is deleted.

- 3. ARTICLE 3.E.3 is deleted.
- 4. ARTICLE 6.A.4 is deleted.
- 5. ARTICLE 8. HOURLY LABOR RATE paragraph 3 is amended to add the applicable pay rate and will read as follows:

"The hourly labor rate for a five (5) persons crew for the term July 1, 2010, through June 30, 2011, is \$150.00. This is the rate to be used by the CONTRACTOR to prepare a bid."

All other terms and conditions of the AGREEMENT remain unchanged {Signature page follows.}

Archer Landscaping Service opted not to participate in fiscal year 2010-11 for personal reasons. JN Land Maintenance, Sierra Landscape, and Tree Elements failed to appear at the mandatory brush contractor's training and orientation. Therefore they are ineligible to participate in the brush clearance program.

Conclusion:

The 14 contractors contained in the attached list have all met the requirements as set forth in the Request for Qualification and the 2008 Agreement; therefore, it is the recommendation of the Fire Department that the Board of Fire Commissioners extend the term of the contract to begin July 1, 2010 and end June 30, 2011.
