### OUR MISSION

The mission of the Los Angeles Fire Department Foundation is to create partnerships to provide resources, programs, services and equipment that assist firefighters and paramedics in protecting life, property and the environment by enhancing their ability to maintain their tradition of service at the highest level.

### WHO WE ARE

The Los Angeles Fire Department Foundation is the major source of private financial support for the Los Angeles Fire Department (LAFD). The Foundation exists to provide funding for the LAFD to support needs not met by the city budget. The goal is to enhance the safety of everyone in Los Angeles.

### THE NEED

Every day the job of the Los Angeles Fire Department gets larger, tougher, more complex and more dangerous. The city budget cannot keep pace. The LAFD's reduced budget is primarily spent on personnel, with little available for major projects that will enhance efficiency and modernization of the department.

The Los Angeles Fire Department (LAFD) is a full-spectrum life safety agency<sup>™</sup> protecting more than 4 million people who live in the second largest city in America. The men and women of the department put their lives on the line to keep us safe, often doing so without adequate equipment or resources.

The LAFD's 3,586 uniformed personnel and non-sworn cadre of 353 professionals protect life, property and the environment through their direct involvement in fire prevention, firefighting, emergency medical care, technical rescue, hazardous materials mitigation, disaster response, public education and community service. They are the first responders for any major catastrophe.

At all times, a total of 1,104 uniformed Firefighters (including 242 serving as Firefighter/Paramedics) are on duty at Fire Department facilities citywide, including 106 Neighborhood Fire Stations strategically located across the Department's 471 square-mile jurisdiction.

In 2009, the men and women of the LAFD responded 753,428 times to come to the aid of their neighbors in need.
