Recommendation: That the Board:

1. Accept a donation from the "Grateful Hearts" Fund Raiser for the members of Fire Stations 72,73,84,93,104,105,106.

Summary: The "Grateful Hearts" fund raiser has donated a Costco gift card to each listed fire station to be used by all members at these fire station locations in the value of \$250.00 each, for a total value of \$1,750.00. Pursuant to the Los Angeles Administrative Code, Article 12, Section 5.111.4(a), "Receipt of Gifts and Bequests of Personal Property by the Fire Department," provides the authority to the Fire Commission to accept or reject bequests of personal property not exceeding \$5,000 in market value.

Fiscal Impact: There is no fiscal impact to the Department's budget in the acceptance of this donation. Members of listed fire station locations shall be responsible to maintain, repair and or replace any item purchased with this donated Costco gift card.

Conclusion: The Los Angeles Fire Department benefits tremendously from gracious donations such as that received from "Grateful Hearts". The Community Liaison Office would like to acknowledge "Grateful Hearts" for this generous donation.





RECOMMENDATIONS
