Recommendation: That the Board:

1. Accept a donation from the Adopt Fire Station 71 (AFS71) 501(c)3 for the members of Fire Station 71.

Summary: The AFS71 501(c)3 has donated carpet, including installation, for Fire Station 71. This carpeting will be placed in all dormitory areas, crew locker room and training room. The combined monetary value of the carpeting and installation is \$3,858.50. Pursuant to the Los Angeles Administrative Code, Article 12, Section 5.111.4(a), "Receipt of Gifts and Bequests of Personal Property by the Fire Department," provides the authority to the Fire Commission to accept or reject bequests of personal property not exceeding \$5,000 in market value.

<u>Fiscal Impact:</u> There is no fiscal impact to the Department's budget in the acceptance of this donation. Members of Fire Station 71 shall be solely responsible to maintain, repair and/or replace these donated items.

<u>Conclusion:</u> The Los Angeles Fire Department benefits tremendously from gracious donations such as that received from the AFS71 501(c)3. The Community Liaison Office would like to acknowledge the AFS71 501(c)3 for their generous donation.
