**Recommendation:** That the Board:

1. Accept a donation from the Adopt Fire Station 71 (AFS71) 501(c)3 for the members of Fire Station 71.

**Summary:** The AFS71 501(c)3 has donated tree trimming services, for Fire Station 71. This service will be utilized to trim trees and hedges on the Fire Station 71 property. The monetary value of this service is \$4,500.00. All work performed by non City contractors will possess a California State contractors license, will sign a City of Los Angeles release of liability and will be bonded and insured as per instructions from Fire Facilities, Building Administration to Fire Station 71 Commanders. Pursuant to the Los Angeles Administrative Code, Article 12, Section 5.111.4(a), "Receipt of Gifts and Bequests of Personal Property by the Fire Department," provides the authority to the Fire Commission to accept or reject bequests of personal property not exceeding \$5,000 in market value.

**Fiscal Impact:** There is no fiscal impact to the Department's budget in the acceptance of this donation. Commanders of Fire Station 71 shall insure all direction from Fire Facilities as to liability will be adhered to.

**Conclusion:** The Los Angeles Fire Department benefits tremendously from gracious donations such as that received from the AFS71 501(c)3. The Community Liaison Office would like to acknowledge the AFS71 501(c)3 for their generous donation.
