Recommendation: That the Board:

1. Accept a donation from the Westin Los Angeles Airport Hotel (WLAH) for the members of the Fire Prevention Bureau (FPB).

Summary: The WLAH has donated (2) treadmills in the value of \$2000.00, (4) stationary bicycles in the value of \$500.00 and various gym equipment in the value of \$1100.00, for the total value of \$3600.00 for the use of all members at the Administration Headquarters gymnasium. Pursuant to the Los Angeles Administrative Code, Article 12, Section 5.111.4(a), "Receipt of Gifts and Bequests of Personal Property by the Fire Department," provides the authority to the Fire Commission to accept or reject bequests of personal property not exceeding \$5,000 in market value.

Fiscal Impact: There is no fiscal impact to the Department's budget in the acceptance of this donation. The FPB shall be solely responsible to maintain, repair and or replace these donated items.


