### **Recommendation:** That the Board:

**Summary:** Mr. Steven Needleman of ANJAC Fashion Buildings has donated a BBQ Grill replacement, BBQ Cover, Granite Countertop and Awning including installation for Fire Station 9. The combined monetary value of these aforementioned items is \$4,421.73. Pursuant to the Los Angeles Administrative Code, Article 12, Section 5.111.4(a), "Receipt of Gifts and Bequests of Personal Property by the Fire Department," provides the authority to the Fire Commission to accept or reject bequests of personal property not exceeding \$5,000 in market value.
