**Recommendation:** That the Board:

1. Accept "Adopt a Fire Station" funding from the LAFD Foundation for Fire Station 69.

**Summary:** The LAFD Foundation has donated four (4) New Television Sets and nine (9) New Mattress Toppers. The combined monetary value of the aforementioned items is \$2,409.54. Pursuant to the Los Angeles Administrative Code, Article 12, Section 5.111.4(a), "Receipt of Gifts and Bequests of Personal Property by the Fire Department," provides the authority to the Fire Commission to accept or reject bequests of personal property not exceeding \$5,000 in market value.

**Fiscal Impact:** There is no fiscal impact to the Department's budget in the acceptance of this donation. The members of Fire Station 69 shall be solely responsible to maintain, repair and/or replace these donated items.
