Submissions, including exhibits, shall not exceed ten (10) pages and must be submitted electronically to apccentral@lacity.org. **Day of Hearing Submissions** after 3:00 p.m. on Thursday before the commission meeting up to and including the day of the meeting are limited to 2 written pages including exhibits and must be submitted electronically to apccentral@lacity.org. Photographs do not count toward the page limitation. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission, and will not be included in the official administrative record for the item at issue.

The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Rules and Operating Procedures and provided that the Commission retains jurisdiction over the case. PUBLIC HEARING REQUIRED

PROJECT SITE: 6008-6010 West Pico Boulevard

PROPOSED PROJECT:

The continued sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 3,373-square-foot restaurant and night club with live entertainment (the Mint). The Project has 97 indoor seats and proposes 18 seats and four tables outdoors in the public right-of-way. The proposed railings to delineate the outdoor dining space will be composed of temporary and removable materials. The Project includes six on-site parking spaces and zero off-site parking spaces. The proposed hours of operation are from 6:00 p.m. to 2:00 a.m., Monday through Friday, and 12:30 p.m. to 2:00 a.m., Saturday and Sunday.

APPEAL:

A partial appeal of the December 21, 2021, a Zoning Administrator's determination which:

- 1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Article 19, Section 15301 (Class 1 – Existing Facilities), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 regarding location, cumulative impacts, significant effects or unusual circumstances, scenic highways, or hazardous waste sites, or historical resources applies;
- 2. Dismissed, pursuant to Section 12.24 W.18, of the Los Angeles Municipal Code (LAMC), a Conditional Use to permit dancing (dance hall) in conjunction with the existing restaurant with live music;
- 3. Approved, pursuant to LAMC Section 12.24 W.1, a Conditional Use to permit the continued sale and dispensing of a full line of alcoholic beverages for on-site consumption with live music in conjunction with an existing restaurant;
- 4. Approved, pursuant to Section 12.27 B and Charter Section 562, a Zone Variance from LAMC Section 12.21 A.4 and 12.21 A.5, to permit the existing six tandem spaces in lieu of the 34 spaces required; and
- 5. Adopted the Conditions of Approval and Findings.

PUBLIC HEARING REQUIRED

PROJECT SITE: 2748 West 8th Street, Units 103, 201, 202

PROPOSED PROJECT:

A Main Conditional Use to permit the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with two karaoke lounges and the sale and dispensing of beer and wine only for on-site consumption in conjunction with one restaurant; and a Conditional Use Permit to allow patron dancing in conjunction with one karaoke lounge establishment, all within an existing commercial development. The venues have a total of 12,126 square feet indoors with 2,448 square feet of outdoor patio space with a total of 436 indoor seats and 92 outdoor patio seats. Proposed hours of operation are from 11:00 a.m. to 4:00 a.m. daily for the two karaoke lounges and 11:00 a.m. to 2:00 a.m. daily for the restaurant.

A partial appeal of the April 19, 2022, a Zoning Administrator's determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15301, and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Approved, pursuant to LAMC Section 12.24 W.1, a Main Conditional Use to permit the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with two karaoke lounges and the sale and dispensing of a beer and wine only for on-site consumption in conjunction with one restaurant all within a shopping center with hours of operations from 11:00 a.m. to 2:00 a.m. daily for the two karaoke lounges and 11:00 a.m. to 2:00 a.m. daily for the restaurant;
3. Approved, pursuant to LAMC Section 12.24 W.18, a Conditional Use Permit to allow patron dancing in conjunction with one karaoke lounge establishment; and
4. Adopted the Conditions of Approval and Findings.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
