Submissions, including exhibits, shall not exceed ten (10) pages and must be submitted electronically to [apccentral@lacity.org](mailto:apccentral@lacity.org). **Day of Hearing Submissions** after 3:00 p.m. on Thursday before the commission meeting up to and including the day of the meeting are limited to 2 written pages including exhibits and must be submitted electronically to [apccentral@lacity.org](mailto:apccentral@lacity.org). Photographs do not count toward the page limitation. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission, and will not be included in the official administrative record for the item at issue.

**PUBLIC HEARING REQUIRED**

**PROJECT SITE:** 607 South Park View Street

**PROPOSED PROJECT:**

Conditional Use Permits to allow the sale and dispensing of a full-line of alcoholic beverages for on-site consumption and for dancing, in conjunction with the use of flexible indoor and outdoor event and performance spaces including for theater, film, and live entertainment within the existing banquet facilities and other accessory uses of the 184,299-square foot historic hotel. Conditional Use Permits are requested for said uses for floors one through five and the basement of the building, totaling 79,541 square feet and 5,133 indoor seats, and 13,739 square feet of outdoor area with 1,001 seats. Hours of operation for alcohol service are from 6:00 a.m. to 2:00 a.m. daily. No new construction, additions, or exterior alterations are being proposed.

An appeal of the June 2, 2022, a Zoning Administrator’s Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15301 Class 1 (Existing Facilities), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Approved, pursuant to Section 12.24 W.1 of the Los Angeles Municipal Code (LAMC), a Conditional Use to authorize the sale and dispensing of a full line of alcoholic beverages for on-site consumption, in conjunction with the operation of the basement through fifth floor of a hotel and special event spaces in the C2-2 Zone;
3. Approved, pursuant to Section 12.24 W.18 of the LAMC, a Conditional Use to authorize patron dancing within the basement through fifth floor in conjunction with the operation of a hotel and special event spaces in the C2-2 Zone, with additional terms and conditions; and
4. Adopted the Conditions of Approval and Findings.

#### **Telecommunication Relay Services**

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
