Photographs do not count toward the page limitation. **Day of Hearing Submissions** after 3:00 p.m. on Thursday before the commission meeting up to and including the day of the meeting are limited to 2 pages plus accompanying photographs. Day of Hearing Submissions are to be submitted electronically to apccentral@lacity.org and 12 hard copies must be submitted at the in-person meeting. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission, and will not be included in the official administrative record for the item at issue.

The Applicant is requesting that the matter be continued to a date certain of November 12, 2024.

PROPOSED PROJECT:

A Conditional Use to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption with ancillary off-site consumption for take-out orders in conjunction with an existing restaurant (La Poubelle Bistro). The subject restaurant is comprised of 3,336 square feet of interior floor area with 90 indoor seats and 289 square feet of outdoor dining with 18 seats located both on private property and within the public right-of-way. Hours of operation are proposed from 9:00 a.m. to 2:00 a.m., daily, along with live entertainment.

2. Authorized herein is the sale and dispensing of a full line of alcoholic beverages for on-site consumption and with the ancillary sale of a full line of alcoholic beverages in conjunction with an existing 3,336 square-foot restaurant and 289 square-foot outdoor eating area. The grant shall be subject to the following limitations:
 - a. The hours of operation shall be limited to 9:00 a.m. to 2:00 a.m., daily., except that use of the outdoor seating shall be limited from 9:00 to 12 midnight daily.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
