PUBLIC HEARING REQUIRED

PROJECT SITE: 6405 West Flagmoor Place; 2855 North Belden Drive

The Applicant is requesting that the matter be continued to a date certain of January 13, 2026.

PROPOSED PROJECT:

Construction, use, and maintenance of a new 2,791 square-foot two-story single-family dwelling with a basement and detached garage on an approximately 6,613 square-foot lot. The single-family dwelling has a proposed overall height of 44 feet and six inches and a proposed residential floor area of 1,647 square-feet. The Project proposes 541 cubic yards (CUYD) of cut, 15 CUYD of fill, zero CUYD of import, and 526 CUYD of export grading. Including the swell factor, the total quantity of soil to be exported will be 581 cubic yards. There is one protected tree on Live Oak, however, it will not be removed. One non-protected tree, a Canary Island Pine Tree will be removed.

APPEAL:

An appeal of the October 6, 2025 Zoning Administrator's Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Article 19, Sections 15303, Class 3, and there is no substantial evidence demonstrating that any exceptions contained in section 15300.2 of the State CEQA Guidelines regarding location, cumulative impacts, significant effects or unusual circumstances, scenic highways, or hazardous waste sites, or historical resources applies;
2. Approved, pursuant to Chapter 1 Section 12.24 X.28 and Chapter 1A Section 13B.2.1 of the Los Angeles Municipal Code (LAMC), a Class 1 Conditional Use Permit to permit the construction, use and maintenance of a new single-family dwelling fronting a Substandard Hillside Limited Street where a minimum 20-foot wide Continuous Paved Roadway is not provided from the driveway apron to the boundary of the Hillside Area as required by LAMC Section 12.21 C.1 0(i)(3);
3. Approved, pursuant to LAMC Chapter 1 Sections 11.5.7 C and 16.50, and Section 9 of the Hollywoodland Specific Plan (Ordinance No. 168,121), and pursuant to LAMC Chapter 1A Section 13B.4.2, a Project Permit Compliance Review and Design Review for the construction, use, and maintenance of a 2,791 square-foot single-family dwelling with a basement, an overall height of 44 feet and six inches and a detached garage on a 6,613 square-foot lot in the R1-1-HCR Zone;

PROJECT SITE: 612 and 618 South Spring Street

PROPOSED PROJECT:

The Applicant is requesting Plan Approval, as required by Condition No. 47 of Case No. ZA-1995-830-CUB-PA4, to allow the continued sale and dispensing of a full line of alcoholic beverages for on-site consumption, in conjunction with an existing nightclub, with no term limit. No change is proposed to the previously approved hours of operation, which were from 8:00 a.m. to 3:00 a.m., with up to 104 events per year where the location is permitted to close at 6:00 a.m. The Project will not expand square footage or change the mode and character of the establishment.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
