**PUBLIC HEARING REQUIRED**

**PROJECT SITE:** 2172 North Stanley Hills Drive

**PROPOSED PROJECT:**

New two-story single-family dwelling with attached two-car garage, swimming pool, and spa. The proposed residence will contain approximately 2,338 square feet in floor area, consisting of 1,030 square feet on the first floor, 1,149 square feet on the second floor, and a 359 square-foot garage (200 square feet is exempt from floor area calculations). The proposed structure will be a maximum of 28 feet in height with a rooftop deck. Site grading includes 437 cubic yards of cut and 322 cubic yards of fill. Lastly, the Project includes the construction of two retaining walls up to 10 feet in height.

**APPEAL:**

**PUBLIC HEARING REQUIRED**

**PROJECT SITE:** 2166 North Stanley Hills Drive

**PROPOSED PROJECT:**

New two-story single-family dwelling with attached two-car garage, swimming pool, and spa. The proposed residence will contain approximately 2,091 square feet in floor area, consisting of 978 square feet on the first floor, 954 square feet on the second floor, and a 359 square-foot garage (200 square feet is exempt from floor area calculations). The proposed structure will be a maximum of 28 feet in height. Site grading includes 410 cubic yards of cut and 320 cubic yards of fill. Lastly, the project includes the construction of two retaining walls up to 10 feet in height.

#### **Telecommunication Relay Services**

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
