PUBLIC HEARING REQUIRED

PROJECT SITE: 11612 - 11618 West Ventura Boulevard

PROPOSED PROJECT:

A Conditional Use Permit request to allow the continued sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 3,849-square-foot restaurant with live entertainment, 117 indoor and 26 outdoor seats. The project is also requesting a Specific Plan Exception to permit zero on-site parking spaces in lieu of 30 spaces otherwise required by the Ventura-Cahuenga Boulevard Corridor Specific Plan. Proposed hours of operation are from 8 a.m. to 10 p.m. on Sundays through Wednesdays; 8 a.m. to 11 p.m. on Thursdays; and 8 a.m. to 1 a.m. on Fridays and Saturdays. The hours of operation for the outdoor patio will be from 8 a.m. to 10 p.m., daily. The project also involves legalizing a change of use from retail to restaurant for a 1,864 square-foot tenant space (inclusive). The project does not involve any exterior alterations or construction to expand the existing building.

REQUESTED ACTIONS:

- Pursuant to California Environmental Quality Act (CEQA) Guidelines, an exemption from CEQA pursuant to CEQA Guidelines Sections 15301 and 15303; and that there is no substantial evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines Section 15300.2 applies;
- Pursuant to Section 12.24 W.1, Los Angeles Municipal Code (LAMC), a Conditional Use Permit to allow the continued sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing restaurant;
- 3. Pursuant to LAMC Section 12.24 W.27, a Conditional Use to authorize hours of operation beyond the 7:00 a.m. and 11:00 p.m. otherwise permitted within a Commercial Corner/Mini-Shopping Center. Proposed hours of operation are from 8 a.m. to 10 p.m. on Sundays through Wednesdays; 8 a.m. to 11 p.m. on Thursdays, and 8 a.m. to 1 a.m. on Fridays and Saturdays. The hours of operation for the outdoor patio will be from 8 a.m. to 10 p.m., daily;
- Pursuant to LAMC Section 13B.4.5.A.2. of Chapter 1A, a Project Exception from the Ventura / Cahuenga Boulevard Corridor Specific Plan, to allow zero parking space in lieu of 30 parking spaces required in Section 7.F.1.c.; and
- 5. Pursuant to LAMC Section 13B.4.2. of Chapter 1A, a Project Compliance Review to permit a change of use from retail to restaurant on a 28,242 square-foot lot.

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico, and the U.S. territories for local and/or long-distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ... "When you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
