These submissions are governed by the City Planning Commission Rules and Operating Procedures posted online at <https://planning.lacity.org/commissioners>. **Initial Submissions**, not limited as to volume, must be received by the Commission Executive Assistant no later than by 4:00 p.m. on the Monday prior to the week of the Commission meeting. **Secondary Submissions**, limited to ten (10) pages, must be received no later than 48 hours before the Commission meeting. **Day of Hearing Submissions**, limited to two (2) pages, are received within 48 hours of the meeting. The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Rules and Operating Procedures and provided that the Commission retains jurisdiction over the case.

PUBLIC HEARING REQUIRED

PROJECT SITE: 3506, 3520, 3506 1/2, 3510, 3524 North Berry Drive

PROPOSED PROJECT:

The Project is for the major remodel and addition of 3,233 square feet to an existing single-family home with a maximum height of 30 feet on a site of approximately 63,716 square feet. The project site is in the Outer Corridor of the Mulholland Scenic Parkway Specific Plan and subject to the Baseline Hillside Ordinance. The Project Site is downslope and Visible from the Mulholland Drive right-of-way. The Project proposes 67 cubic yards of cut, 13 cubic yards of fill, 54 cubic yards of export, and zero cubic yards of import grading. The Project proposes the removal of one non-protected significant tree, which is required to be replaced on a 1:1 basis.

APPEAL:

An appeal of the Zoning Administrator's Determination, dated October 31, 2025, which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301, Class 1 (Existing Facilities) and Section 15303, Class 3 (New Construction or Conversion of Small Structures), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Approved, pursuant to Chapter 1 Section 12.24 X.28 and Chapter 1A Section 13B.2.1. of the Los Angeles Municipal Code (LAMC), a Class 1 Conditional Use to allow the major remodel and to an existing single-family home on a hillside lot fronting an existing Substandard Hillside Limited Street (Berry Drive) without providing a 20-foot-wide Minimum Adjacent Roadway as required by Section 12.21 C.10(i)(2) and without providing a minimum 20-foot-wide Continuous Paved Roadway from the driveway apron to the boundary of the Hillside Area as required by Section 12.21 C.10(i)(3);
3. Approved, pursuant to LAMC Chapter 1 Section 11.5.7.C and Chapter 1A Section 13B.4.2. and Chapter 1 Section 16.50, Chapter 1A Section 13B.4.3, and Section 11 of the Mulholland Scenic Parkway Specific Plan (Ordinance No. 167,943) and based upon the recommendation of the Mulholland Design Review Board, a Project Permit Compliance and Design Review Board for the major remodel and addition of 3,233 square feet to an existing single-family home with a maximum height of 30 feet on a site of approximately 63,716 square feet; and
4. Adopted the Conditions and the Findings.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico, and the U.S. territories for local and/or long-distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Do not hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." When you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
