**Public Comment.** Members of the public are invited to address the Emergency Operations Board (“EOB” or “Board”) during the public comment period on any specific item of business on the meeting agenda and/or on matters within the subject matter jurisdiction of the Board (i.e., general public comment). Members of the public who wish to speak shall check-in with the Board Secretary. Only those speakers who have checked-in at the time the Board Chairman opens the public comment period will be permitted to speak. All public comment shall be taken in person and completed at or near the beginning of each meeting.

Members of the public who wish to speak on specific agenda items shall be allowed to speak for up to one minute per item, up to a total of two minutes for each meeting. Additionally, members of the public who wish to provide general public comment on matters within the subject matter jurisdiction of the Board shall be allowed to speak for up to a total of one minute for each meeting. A maximum cumulative total of up to three minutes for both agenda item and general public comment shall be afforded each speaker. Time cannot be ceded to another speaker and a person can only speak once during the meeting.

**Accommodations.** Requests for reasonable accommodation for individuals with disabilities consistent with the Americans with Disabilities Act can be made by contacting the Emergency Management Department at (213) 484-4821. Please make your request at least 72 hours prior to the meeting you wish to attend.
